1. Title of the Promotion

Eventrend Group Bucketlist Collection

2. Procedure of the Promotion

2.1 You can get a Bucketlist Collection city map from the following sources:

- Paper map: For a paper map: in participating restaurants and Budapest Card counters in several locations in Budapest
- Online map: Download it to your phone from <https://bucketlistbudapest.hu/>

The voucher on the city map can be redeemed immediately at the first restaurant you visit.

2.2 How can you join the Promotion as a Participant?

- By showing the Bucketlist Collection city map
- By presenting the purchased Budapest Card 24 / 48 / 72 / 72Plus / 96 / 120 at the participating restaurants

2.3 What is the content of the Promotion?

The gift is a glass of a glass of Prosecco for each Participant over the age of 18 who consumes at least one dish chosen from the venue's menu. One card entitles the holder to 4 free glasses of Prosecco per person (with a minimum of 1 menu item per guest). For larger table groups, more than one map coupon can be used at a time.

No minimum consumption value is attached to the consumption of a meal.

The Promotion is valid for the duration of your stay in Budapest at any of the restaurants listed on the Bucketlist Collection city map without any restrictions:

- **All 8 coupons are redeemable:** you can visit all the restaurants included in the Promotion
- **Redeemable more than once in a day:** stop at any of the restaurants you come across while sightseeing.
- If you wish, return to a restaurant several times and redeem your voucher.

Participating establishments will serve the same brand of Prosecco.

You can visit the restaurants without making a reservation.

2.4 How can you redeem a coupon for the Promotion?

After placing the meal order, the gift Prosecco will be served before or during the meal, as requested by the Participant.

The gift Prosecco on the coupon cannot be exchanged for cash or any other beverage. Its value cannot be deducted from the total amount of the consumption invoice.

The Participant will have no payment obligation in relation to the gift Prosecco and the value of the gift Prosecco will be 0 Ft/ 0 EUR on the invoice issued for the consumption.

3. Duration of the Promotion

The promotion will start on 1 April 2023 at 00.00.00 and will run until 30 April 2024 at 23.59.59.

The Promoter reserves the right to withdraw this Promotion without notice in the event of force majeure (war, earthquake, disaster, strike or similar unexpected and extraordinary event).

5. Persons participating in the Promotion:

The Promotion is open to all natural persons over the age of 18 who have the capacity to participate in the Promotion (hereinafter referred to as "Participant").

Under the legislation in force in Hungary, the managers of the participating establishments have the right to request a photo identification document and to verify the age of the Participant in case of doubt as to whether the Participant is over 18 years of age.

6. They are not eligible to participate in the Promotion:

6.1 Managers and employees of the organizing company, as well as the relatives of the persons listed herein, as defined in the interpretative provisions of the Civil Code (Civil Code. 8:1.§ (1) (2)).

6.2 Other companies directly involved in the organisation and running of the Promotion, as well as owners, managers, employees of catering establishments participating in the Promotion and their relatives as defined in the interpretative provisions of the Civil Code (Civil Code, Art. 8:1.§ (1) (2)).

7. Acceptance of the rules of the Promotion

8. Responsibility

The Promoter and the agents of the participating establishments in the Promotion shall not be liable in connection with the use of the Game application in the following cases:

- Participation in the Promotion and the consumption of Prosecco with an alcohol content of 11.5% is at the Participant's own risk, as the Promoter does not request or handle data on the Participant's medical condition in advance.
- The Participant acknowledges that there is a zero tolerance for alcohol abuse in Hungary if he/she participates in the transport with his/her own or rented vehicle (car, electric scooter, bicycle). In case of violation of this rule, the Promoter or the catering establishments participating in the Promotion are not liable for any damage to their own or others' physical safety or for any damage to property.
- Neither the Promoter nor any of the companies involved in the running of the Promotion by the Promoter shall be liable for, and excludes all claims for, damages or compensation for any costs, damages or losses arising out of or in connection with participation in the Promotion, any errors, defects or malfunctions in the Promotion, or any delays in the Promotion.

9. Processing of data in connection with the Promotion

Scope of data processed:

- The provision of personal data by the player is voluntary at all times. Providing personal data is not a condition for the delivery of a glass of Prosecco at the participating restaurants.
- If the Participant wishes, he/she may reserve a table in advance through the reservation system of each establishment. In this case, the data processing is governed by the data processing policy of the respective catering establishment.
- The online map can be downloaded from the website <https://bucketlistbudapest.hu/> after registration by entering your first name and e-mail address. This data may be used by the Organizer Eventrend

Marketing & Sales House Kft. to promote the Promotion by message during the stay in Budapest.

The data provided will only be used by the Organiser for the purposes specified in these Promotion Rules and will not be processed or handled for purposes other than those specified herein.

The data will be kept for a maximum of 1 year, after which it will be destroyed.

Further rights and remedies of the Participants in relation to data management are set out in Articles 14 and 16 of Act CXII of 2011 (Infotv.).

10. Tax issues

Taxes and contributions in connection with the Promotion are borne by the Promoter, and no other related taxes are payable by the Participant.

11. Complaints handling

If the Participant of the Promotion has any complaints regarding the Promotion, please report them to the manager of the catering establishment visited. He will do his best to resolve your complaint on the spot.

12. Other information related to the Promotion

During the Promotion, the Participant is aware of the difficulties arising from the nature, limited capacity, limited access, downtime, technical limitations and any related technical and operational reasons of electronic data transmission.

The Promoter also accepts no liability if participation in the Promotion is delayed or not completed due to system congestion, Internet connection interruption or any other technical failure or impediment beyond the control of the Promoter. If the Participant closes the browser window while registering, downloading or disconnects from the server's website, the Promoter shall not be liable for any loss of data.

The Promoter reserves the right to amend or modify these terms and conditions or the Promotion itself, solely to make the terms and conditions of the Promotion more favourable to Participants or to comply with changes to the Promotion Rules in accordance with applicable law during the Promotion Period. All matters not covered by these Promotion Rules shall be governed at all times by the laws of Hungary in force.

These Promotion Rules shall be governed by the laws of Hungary and any disputes arising in connection with the participation shall be settled by the ordinary Hungarian courts having jurisdiction and competence pursuant to Act CXXX of 2016 on Civil Procedure.
